

Wireman's Licence

Documents required:-

- Letter addressed to the Chief of Training EWA with the candidate's Name, CPR №, Mobile №, and work experience, signed by the company Owner or Director with the company stamp.
- Original qualification Certificate, with photocopy attested & signed by the company owner
- Qualification must be in Electrical (Only)
- CPR Smartcard printout (dated within 7 days) with clear photo
- Photo 30 x 35 on white background With CPR Nº & Name written on the reverse side of the photo
- Must be registered in the Ministry of Labour if unemployed on the date of application submission

Qualifications:- Electrical Engineering Only from a Government or State Approved Institute (Level 5 NQF).

- For Bahraini Nationals the minimum accepted qualification is the Tawjihi (Electrical) certificate.
- All Candidates must be over 18 years of age and less than 70 as licence will automatically expire after 70 years of age

After approval of all submitted documentation:-

- Candidates attend the written examination on the date specified
- Successful candidates will then be notified of the date for the practical test.
- In case of <u>not being able to attend</u> the test on the <u>assigned date</u>, the Licensing Unit <u>must</u> be informed <u>in writing</u> at least <u>one week before the test date</u>. Failure to do so will <u>result in loss of fees</u>, and the <u>re-application</u> for a <u>new test date</u> upon <u>re-payment of the appropriate fee</u>.
- Successful candidates will be issued with the Electrical Wireman's Licence valid for five (5) years.
- This test will be conducted in either Arabic or English

Plumber's Licence

Documents required:-

- Letter addressed to the Chief of Training EWA with candidate's Name, CPR №, Mobile №, and work experience, signed by the company Owner or Director with the company stamp.
- Practical experience for a minimum of one year acquired through continuous work in the field of
 internal water networks for houses, commercial or industrial shops, provided that the applicant
 must submit a certificate to prove the same issued in the official documents of the entity where
 he had been working and duly stamped.
- Must be registered in the Ministry of Labour if unemployed on the date of application submission
- CPR Smartcard printout (dated within 7 days) with clear photo
- Photo 30 x 35 on white background With CPR No & Name written on reverse side of the photo

<u>Qualifications:-</u> Plumbing, Pipefitting or related qualification only from a Government or State Approved Institute (**Level 5 NQF**).

- For Bahraini Nationals the minimum accepted qualification is the Tawjihi certificate.
- All Candidates must be over 18 years of age and less than 70 as licence will automatically expire after 70 years of age

Fee to repeat the Written or Practical Exam - 10 BD

Plumber License Application Procedure:-

After approval of all submitted documentation:-

- Candidates will attend a 4-hour Water Regulations briefing session on the date specified.
- Following the lecture, candidates will be required to sit for a written examination
- Successful candidates will then be notified of the date for the practical test.
- In case of <u>not being able to attend</u> the test on the <u>assigned date</u>, the Licensing Unit <u>must</u> be informed <u>in writing</u> at least <u>one week before the test date</u>. Failure to do so will <u>result in loss of fees</u>, and the <u>re-application</u> for a <u>new test date</u> upon <u>re-payment of the appropriate fee</u>.
- Successful candidates will then be issued with the Plumber's Licence valid for five (5)
 years
- This test will be conducted in Arabic or English

Candidates that fail to reach the required level of competency in either the theoretical or practical examination will be required to repeat that component only.



Installation Engineer's Licence

- Original Degree (BSc. NQF Level 8) in Electrical Engineering only, attested, stamped, and signed by the company Owner/DirectorCopy both sides of the candidate's CRPEP Licence
- CPR Smartcard printout (dated within 7 days) with clear photo
- Photo 30 x 35 on white background With CPR No & Name written on the reverse side of the photo.
- Must be registered in the Ministry of Labour if unemployed on the date of application submission
- All Candidates must be over 18 years of age and less than 70 as licence will automatically
 expire after 70 years of age

- Photo 30 x 35 on white background With CPR No & Name written on the reverse side of the photo.
- Must be registered in the Ministry of Labour if unemployed on the date of application submission
- All Candidates must be over 18 years of age and less than 70 as licence will automatically
 expire after 70 years of age

License Application Procedure:-

- Original qualification Certificate in <u>Electrical Engineering (NQF Level 5)</u> with photocopy attested, stamped, and signed by the company Owner/Director
- CPR Smartcard printout (dated within 7 days) with clear photo
- Photo 30 x 35 on white background With CPR No & Name written on the reverse side of the photo

Qualifications:- Electrical Engineering Only from a Government or State Approved Institute (Level 4 QCF).

- For Bahraini Nationals the minimum qualification is the Tawjihi (Electrical) certificate.
- All Candidates must be over 18 years and less than 70 years of age.
- Candidates must have a minimum of one-year cable related work experience.
- Where cable-jointing related work experience is not available (e.g., job seekers),
 candidates must have attended an <u>approved</u> cable-jointer training course
- Licences will automatically expire after 70 years of age

- M.V. (11 kV) Written Test 10 BD + M.V. (11 kV) Practical Test 400 BD

License Application Procedure:-

After approval of all submitted documentation:-

- Candidates will attend the relevant written examination on the date specified
- Successful candidates will then be notified of the date for the practical test
- In case of <u>not being able to attend</u> the test on the <u>assigned date</u>, the Licensing Unit <u>must</u> be informed <u>in writing</u> at least <u>one week before the test date</u>. Failure to do so will <u>result in loss of fees</u>, and the <u>re-application</u> for a <u>new test date</u> upon <u>re-payment of the appropriate fee</u>.
- Successful candidates will be issued with the applicable Cable-jointer's Licence valid for five (5) years.
- This test will be conducted in English only

Candidates that fail to reach the required level of competency will be required to re-take the relevant examination on payment of the appropriate fees according to the set procedures



Electrical Wireman's Licence:-

For Licences expired up to one year after renewal date, the candidate must submit:-

- The Original License
- CPR Smartcard printout (dated within 7 days) with clear photo
- Photo 30 x 35 on white background With CPR No & Name written on the reverse side of the photo.
- Pay *renewal fee* BD 10

For Licences expired <u>more than one year (1), but less than five (5) years</u> after renewal date, the candidate must submit:-

- The Original License
- CPR Smartcard printout (dated within 7 days) with clear photo
- Photo 30 x 35 on white background With CPR No & Name written on the reverse side of the photo.
- Pay written test fee BD 10 (including licence issue fee)
- In case of <u>not being able to attend</u> the test on the <u>assigned date</u>, the Licensing Unit <u>must</u> be informed <u>in writing</u> at least <u>one week before the test date</u>. Failure to do so will <u>result in loss of fees</u>, and the <u>re-application</u> for a <u>new test date</u> upon <u>re-payment of the appropriate fee</u>.

Cable Jointer's L.V. & M.V. (11 kV) Licences:-

- Pay renewal fee BD 10

For Licences expired <u>more than one-year (1), but less than five (5) years</u> after renewal date, the candidate must submit:-

- The Original License
- CPR Smartcard printout (dated within 7 days) with clear photo
- Photo 30 x 35 on white background With CPR No & Name written on the reverse side of the photo.
- Pay written <u>test fee</u> BD 10 (including licence issue fee)
- In case of <u>not being able to attend</u> the test on the <u>assigned date</u>, the Licensing Unit <u>must</u> be informed <u>in writing</u> at least <u>one week before the test date</u>. - Photo 30 x 35 on white background With CPR No & Name written on the reverse side of the photo.
- Pay *renewal fee* BD 10

For Licences expired <u>more than one-year (1), but less than five (5) years</u> after renewal date, the candidate must submit:-

- The Original License
- CPR Smartcard printout (dated within 7 days) with clear photo
- Photo 30 x 35 on white background With CPR No & Name written on the reverse side of the photo.
- Pay written test fee BD 10 (including licence issue fee)
- In case of <u>not being able to attend</u> the test on the <u>assigned date</u>, the Licensing Unit <u>must</u> be informed <u>in writing</u> at least <u>one week before the test date</u>. For Licences expired more than one year (1), after renewal date, the candidate must submit:-

- The Original License
- CPR Smartcard printout (dated within 7 days) with clear photo 3 copies
- Photo 30 x 35 on white background With CPR No & Name written on the reverse side of the photo.
- Pay written test fee BD 10 (including licence issue fee)
- In case of <u>not being able to attend</u> the test on the <u>assigned date</u>, the Licensing Unit <u>must</u> be informed <u>in writing</u> at least <u>one week before the test date</u>. Failure to do so will <u>result in loss of fees</u>, and the <u>re-application</u> for a <u>new test date</u> upon <u>re-payment of the appropriate fee</u>.
- This test will be conducted in English only
